### **Lieutenant Governor Sheila Oliver**

Self-described as a "Jersey Girl", Lieutenant Governor Oliver has pioneered a successful career in public service advocating for social justice, women's equality, and education, ultimately becoming the first woman of color to serve in a statewide elected office in New Jersey history. In addition to her role as Lieutenant Governor, she serves as Commissioner of the Department of Community Affairs. In her keynote speech, the Lt. Governor addresses the importance of shifting our focus to designing "complete streets" that are safe for all bikers and walkers of all ages, abilities, and income levels. She shares the many DCA services and programs available to municipalities to build safer, stronger, and more bike/ped-friendly communities.

### **U.S. Representative Mikie Sherrill**

Rep. Mikie Sherrill graduated from the Naval Academy and served in the Navy for almost 10 years as a Sea King helicopter pilot and Russian policy officer. She went on to attend Georgetown University Law School and serve as a federal prosecutor at the US Attorney's Office in Newark, NJ. She serves on the House Armed Services, Science, Space and Technology, and Education and Labor Committees. She proudly owns the title of the "tunnel-obsessed Congresswoman" due to her tireless advocacy for infrastructure investments crucial to Northern New Jersey and the entire country. In her address, Rep. Sherrill will focus on the importance of prioritizing these investments to reimagine how our communities can work better for all people and ensure we're paving the way for the future in a sustainable manner.

### SafeRoutes 12:00 - 1:00 PM - A VISION FOR SAFETY: THE NEW JERSEY STRATEGIC **HIGHWAY SAFETY PLAN**

New Jersey's vision is to achieve zero deaths on all public roads. Join us for an update on the New Jersey 2020 Strategic Highway Safety Plan which includes goals, objectives, performance measures and a specific bicycle and pedestrian emphasis area to guide safety programs and investments and help reduce highway fatalities and serious injuries on all public roads. This wide-ranging plan focuses not only on physical improvements to the roadway system in order to reduce the frequency and severity of crashes, but also includes education and outreach efforts aimed at changing road user behavior to promote a culture of safety.

The pandemic spurred tremendous innovation in tactical approaches to expand the capacity of our streets to accommodate people and commerce more safely. These experiments validated the demand for complete streets that provide a better balance between roadway users. At the same time, many of these pilots highlighted real conflicts that need to be thought through more thoroughly if they are going to transition to permanent solutions. Closer to home, Hoboken has also eliminated traffic fatalities for three years running. So, yes Vision Zero is achievable. What exactly is Vision Zero and why should it be a part of our transportation policy in New Jersey?
